## ACCESSCNY ADDS ONONDAGA CASA TO SUPPORT CHILDREN IN FOSTER CARE

Earlier this year AccessCNY added Onondaga CASA as a new program. CASA or Court Appointed Special Advocates, provides volunteer advocates for children in the foster care system who have been abused or neglected.

Established in 1997, Onondaga CASA is comprised of community-based volunteers who are trained and swornin by a Family Court Judge to advocate for the best interests of children. For many abused children, their CASA volunteer will be the one constant adult presence in their life until a safe and permanent home is achieved.

Onondaga CASA is a lifeline to children in the foster care system and continues AccessCNY's vision to adapt as the needs of our community change. This partnership will help children and families served by CASA connect with other AccessCNY programs that could benefit a child or parent with a developmental disability or mental

health diagnosis. These supports will help move the family forward. Syracuse is one of the nation's most impoverished cities; by growing the CASA program we can create more stability for children and help move our community forward.

Each year more than 300 children experience foster care in Onondaga County; far more than can be supported by CASA. As a result, CASA volunteers are assigned to the most difficult cases. AccessCNY hopes to grow the number of children served by the program.

### **ACCESSCNY** TRAINS FIRST RESPONDERS TO IMPROVE ENCOUNTERS WITH THOSE IN MENTAL HEALTH CRISIS

Over the course of the last three months. AccessCNY's Crisis Intervention Team (CIT) has trained over 60 law enforcement officials and first responders on how to best de-escalate an encounter with someone in a mental health crisis.

Started earlier this year, CIT is a collaboration between AccessCNY and the Central New York Care Collaborative. CIT training uses evidence-based approaches to improve relationships between those with a mental health diagnosis or disability and law enforcement officials. The goal of CIT is to inform first responders about community-based resources in order to keep those in crisis out of the justice system or emergency room and reduce the potential of injury.

Captain John Cooney is retired from the City of Troy Police Department and is the Law Enforcement Coordinator of AccessCNY's CIT program. "The Crisis Intervention Team training supplies officers with an additional tool on their belt. De-escalation skills lead to less use of force, thus reducing the potential for officer and citizen injury. The program brings community resources, mental health professionals and our sworn protectors together to improve the lives of those with a mental health

diagnosis. By bringing this training to six counties across Central New York we will blanket the region with compassionate, efficient and empathetic response and follow up."

In addition to the weeklong trainings, a truncated series makes the training more accessible to time-strapped officers. As part of CIT, AccessCNY also convenes monthly meetings with representatives of local police and the Justice Center, local emergency providers, family members, individuals with mental health disorders and other community partners. The advisory committee discusses community and police relations regarding mental health disorders, training needs and feedback regarding services and interactions from first responders.

AccessCNY plans to train 500 law enforcement officers and first responders across six counties over the course of two years. The next week-long CIT Training will be offered in January.
