

SUMMARY ANNUAL REPORT FOR ACCESSNY, INC. WELFARE PLAN

This is a summary of the annual report of the ACCESSNY, INC. WELFARE PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 15-0532247, Plan Number 509), for the plan year 05/01/2019 through 04/30/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with LINCOLN LIFE & ANNUITY COMPANY OF NEW YORK, EXCELLUS BLUECROSS BLUESHIELD, THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA and UNITEDHEALTHCARE INSURANCE COMPANY to pay certain Long-term disability, Health, Prescription drug, Life insurance, Accidental Death & Dismemberment, Temporary disability, Dental, Vision, Voluntary Life and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 04/30/2020 were \$3,881,631.
